Training Agreement

The following is an agreement between Homeward Hound, LLC (Homeward Hound) and the undersigned. By signing below (electronically or on paper) you agree to uphold the terms of this agreement. The purpose of this agreement is to state the terms and conditions under which Homeward Hound's Training Team will provide training for your dog. The terms and conditions are as follows:

Homeward Hound's Training Team shall provide professional consultative and instructional services for the dog(s)' owner(s), consisting of teaching canine behavioral theory, dog and leash handling, basic commands, humane corrections, positive praise, and/or recognition of undesirable canine behavior and administration of proper behavior modification techniques.

1. I understand and agree that it is critical to cooperate fully in completing all training sessions scheduled for each program. I understand and agree that my dog(s) may not perform to the level expected after completion of chosen training schedule. I am responsible for maintaining my dog(s) training practices at home, pursuant to my trainer's instruction.
2. I understand and agree that not all dogs are trainable to the same extent, and that the ability to train a dog to an acceptable level of performance may be dictated by factors beyond the control of the trainer. Such factors may include, but are not limited to, age, previous conditioning, breeding, physical and psychological health, individual temperament, length of training schedule, and client involvement. Homeward Hound shall not be held responsible for poor dog training performance due to limitations beyond the control of trainer.
3. I agree to disclose any episodes where my dog(s) have harmed, shown aggression, or exhibited any threatening behavior towards any dog or person. A behavioral assessment will be conducted to help determine each dog(s) behavior before training begins. Homeward Hound, LLC reserves the right to refuse a dog(s) if it appears to us that such dog(s) behavior could jeopardize the safety of our staff.
4. In the event of an accident or injury to my dog I agree that in the absence of negligence, to not hold Homeward Hound or its affiliates liable for injury to my dog or injury to another dog caused by my dog.
5. I agree to assume financial responsibility, and any reimbursements therein, to Homeward Hound or its employees for any and all damages, injuries, and losses caused by my dog while in training with Homeward Hound.
6. In the event emergency veterinary care is required for my pet, I agree to transport and to assume full financial responsibility of any costs incurred.
7. I confirm that my dog(s) are in good health. Dog(s) will not be trained that do not appear to be in good health. Any dog(s) over age ten will require a written letter from their veterinarian certifying that they are healthy enough for training.
8. I understand and agree that if I interrupt or delay the training schedule for any reason, or if my dog becomes ill, Homeward Hound's trainer reserves the right to halt the training program without being liable to the owner. When the issue causing the delay is resolved, the dog training may be continued at no additional cost. If the interruption in training is due to illness of the dog, training will be resumed only after a veterinarian certifies that the dog's health will permit resumption of training. I agree that interruptions in the chosen training schedule may have an adverse effect upon the performance level of my dog upon completion of the schedule. Further, I agree that if the schedule is interrupted it may be necessary to expand the schedule in order to achieve a desirable

level of performance at an additional cost to myself. If any delay or interruption in training is at the request of the trainer you will not be billed for any delays or interruptions.

9. I confirm that my pet is fully vaccinated against Rabies. Furthermore, I have provided documentation from a veterinarian certifying so.
10. In the event my dog(s) contracts a communicable disease while training with Homeward Hound, I assume the risks and accept responsibility for the costs for all treatments. I also agree to withhold my dog(s) from training until they have been free of any signs of communicable disease for at least 48 hours. I understand the risks of my dog acquiring communicable diseases are small, in the absence of negligence I accept them and agree to hold Homeward Hound harmless from expenses incurred for treatment.
11. I understand any photos taken of my dog while in training with Homeward Hound could be used for marketing purposes by Homeward Hound, including but not limited to, posting to Homeward Hound's Facebook and Instagram page or website.
12. I agree to pay for training up front. If payment is not received in a timely manner I understand Homeward Hound may deny training services until payment is received in full. I understand Homeward Hound will charge me \$35 for any returned check for insufficient funds or my credit card is denied.
13. I understand that Homeward Hound holds my privacy and personal information in the strictest confidence and will not share my information with any third party without first obtaining my written authorization. I understand Homeward Hound follows all state and federal privacy laws.
14. I certify that I am the owner of the dog(s) (names listed below) and that I am fully authorized to enter into this Agreement with Homeward Hound. All of the information about my dog(s) in this Agreement is true, accurate and complete.
 - a. To the best of my knowledge, my dog(s) have not been exposed to Rabies, Distemper, Kennel Cough or any other contagious illness within 30 days prior to beginning training.
 - b. To the best of my knowledge my dog(s) have no illnesses or behavioral problems that have not been disclosed to us.
 - c. I agree to indemnify and hold Homeward Hound, LLC harmless from and against all loss, damage or expense, including attorney's fees, resulting from misrepresentations by you or your representatives from your dog(s) stay including, without limitation, any person claiming to be the owner of your dog(s) and any person claiming damage or injury by your dog(s).

By signing below, I agree that I have read and understand this entire Agreement and have had the opportunity to discuss it with Homeward Hound to my satisfaction and agree to its terms and conditions.
